It is notified for information of all concerned that as per the UGC notification F.1-18/2010(CPP-II) dt. 23.07.2018 for promotion of Academic Integrity and Prevention of Plagiarism in Gauhati University, a Committee i.e. Institutional Academic Integrity Panel (IAIP) as per the UGC Regulation has been constituted with the following members.

1. Chairman - Prof. M.P. Bezbaruah, Deptt. of Economics, G.U.
2. Member - Prof. M.P. Bora, Head, Deptt. of Physics, G.U.
3. Member - Registrar, Cotton University.
4. Member - Prof. Pradeep Phukan, Deptt. of Chemistry, G.U.

The tenure of the committee members including Chairman shall be 3 (three) years. The quorum for the meeting shall be 3 out of 4 members (including Chairman).

The IAIP shall consider the recommendations of DAIP.

The IAIP shall also investigate cases of plagiarism as per the provisions mentioned in these regulations.

The IAIP shall follow the Principles of natural justice while deciding about the allegation of plagiarism against the student, faculty, researcher and staff of Gauhati University.

The IAIP shall have the power to review the recommendations of DAIP including penalties with due justification.

The IAIP shall send the report after investigation and the recommendation on penalties to be imposed to the Vice-Chancellor within a period of 45 days from the date of receipt of recommendation of DAIP/complaint/initiation of the proceedings.

The IAIP shall provide a copy of the report to the person(s) against whom inquiry report is submitted.
