The appointee having Post Graduate Degree in specific Subject, who is appointed in the Higher Secondary School, will have to take up classes in Higher Secondary Section too, if so, assigned by the Head of the Institution as per the provision of Govt. OM No. ASE.242/2012/24, dated 10.05.2012.

The appointee concerned shall also have to furnish Joining Report alongwith an undertaking before the undersigned as prescribed by the Finance (Budget) Department vide letter No. B.W.3/Pt-II/1, dtd. 25.01.2005 regarding acceptance of "New Pension Scheme" as follows:-

*"I understand and accept that Government servant joining the service in the State Government on or after 01.02.2005 shall not be governed by the existing Assam Service (Pension) Rules, 1969 and orders issued there under from time to time and that their pension and other retirement benefits will be governed by a set of New Pension Rules, which are being introduced in the line with the Contributory Pension Scheme of Government of India".*
