Among other things, this mechanism shall also include cheques to be issued to the following persons/cases:

- a. Students.
- b. TA/DA, remuneration & honorarium as applicable as per rules to all faculty, examiners, experts, officers, employees etc.
- c. Contractors/Vendors/Suppliers.
- d. Payments with regard to projects/studies etc. by G.U. faculty members.
- e. Conference/seminars/workshops etc.

However, exceptions shall be made in case of the following:

- a. Where the payee is a designation of a sanctioned post only of GU.
- b. In other special circumstances with the approval of Hon'ble Vice-Chancellor.
