The terms of reference of the task force shall be as under:

- i. To consider the pension related problems being faced by such teachers who had joined GU after applying through proper channel (without any break in service) but had joined their past organizations before 1-2-2005.
- ii. To cause to prepare, all financial statements/worksheets and all other necessary documents, individually for each such teacher, so that they can be covered under pension scheme in consonance with GU Amendment Act 2013.
- iii. To recommend to GU authority, the amounts to be recovered/paid by the past organizations / teachers concerned, to GU, so as to enable the concerned teachers to come under the purview of pension scheme in consonance with GU Amendment Act 2013.
- iv. To recommend to GU, any other step/action/policy that may be required to ensure that all such teachers can come under the purview of pension scheme of GU.

The task force is requested to carry out its activities in mission mode and submit its report within two months from the date of notification.
