2. The structure and format of M.Phil. Dissertation should be as per Clause no. 7.4 of G.U. M.Phil./Ph.D. Regulations, 2016.
3. 2 copies ( 3 copies in case of co-guide) of dissertation with both side printing for evaluation.
4. The final copy (Library copy) to be printed on single side with double space after successful completion of viva-voce.
5. Soft copy of the dissertation in C.D. (only in continuous single PDF file)
6. Paper/cloth light binding at black colour for Arts/Commerce/Fine Arts/Management/Law and Dark-Cherry –red for Science/Technology/Medical & Engineering in(white letter/A4 size paper)
7. The library clearance certificate in Original
8. The department clearance certificate from HOD in original
9. Self Attested photocopy of either original Master Degree certificate or provisional Master Degree certificate.
10. Self Attested photocopy of G.U. Registration Certificate.
11. Examination fees (Dissertation) receipt of Rs.2000.00. This is exempted for the session 2017-18 only.
12. Admission fee receipt
13. Laboratory clearance certificate
14. Hostel clearance certificate from the Secretary University Classes, G.U. and non-boarder certificate from the Head of the Department.
15. Anti Plagiarism Certificate in Original from the Librarian, G.U.
16. Certificate from the guide stating that same soft copy is submitted to the Library for checking plagiarism.
17. Self Attested photocopy of Coursework certificate.
18. Acknowledgement of panel submitted by the Supervisor which has to be collected from the office of the undersigned.
